



## AA-Partners Life Settlement Index: Reporting per 30.03.2012

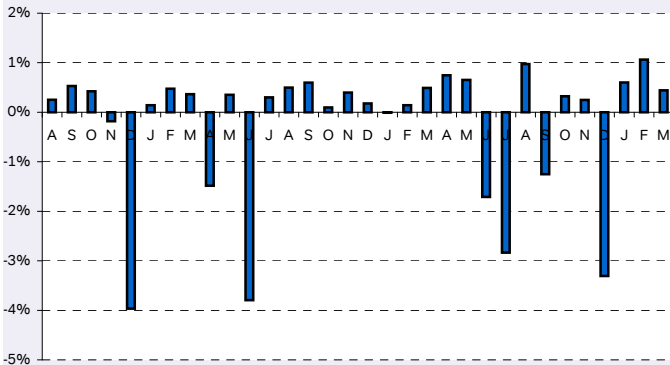
### SHORT DESCRIPTION

The AAP Life Settlement Index tracks the performance of funds implementing an investment strategy in the US life insurance sector and serves as a benchmark for investments in traded US life insurances. The calculation is done using the NAVs of the index components which are equally weighted as per each calculation date. The index is calculated in USD and starts with a value of 100 as per end of December 2006.
